Aloha Blake,

I want to advise you that we sent a letter to Comcast's local counsel, Carlito Caliboso, advising them that we needed to extend our decision making from Sept. 19 to Sept. 30, 2014. Although we made them aware of the need for more time during our meetings with them last week, they made it clear they were very much against such a move on our part. The extension requires mutual agreement by all parties.

I'm letting you know about this because I presume Comcast may reach out to the Governor regarding their concerns. I am very concerned that based on our discussions with Comcast, that if pushed by them to issue an order by Sept. 19, the order we would be forced to issue would be a denial of the transfer. Not because we intend to deny it, but because we need the additional time to carefully craft the transfer order that will protect the State, the public and consumers in general.

Comcast is clear that we are trying to work with them to effectuate a transfer order that works for Hawaii and, where possible, does not impact their efforts for a national transfer merger.

Please do let us know if Comcast does reach out to the Governor or if you require additional information.

HOT BUTTON / NOTEWORTHY ISSUES:

(Regulated Industries Complaints Office) – Dentist Lily Geyer and Order to Compel filed in court. Star Advertiser ran a front page story yesterday about the dentist Lily Geyer matter and that DPS Narcotics Enforcement Division is investigating Geyer. The story also reported that RICO has filed a motion to compel the testimony of two former employees who may have information relevant to the investigation.
